Neighborhood Safety On-Street Parking

FWOA is getting lots of complaints about parking and speeding. Probably most notable is the parking that occurs on curves, and especially on Lawton but elsewhere as well. On Lawton, drivers approaching the curve cannot see the on-coming traffic because of the parked cars, and in any event it's hard to move three cars through the curve, and this becomes a real danger. Should we amend the by-laws to limit on-street parking? I think FWOA is empowered to make rules to assure the safety of residents, but this is another issue where we could use some legal advice.

Other issues revealed to the FWOA by residents include commercial vehicles parked on the streets. We have found that some neighbors who are affected by it are severely stressed. They say it looks bad and therefore threatens property values, and that it also is inconvenient for homeowners backing our of their driveway.

Other complaints include overnight parking on the streets.

Speeding

FWOA also gets complaints about speeding. The speed limit, as stated in our by-laws, is 25MPH. It has been suggested we ask the Sheriff's Department to conduct random radar checks so please be aware and please help control the speed. There is some interest on the board in regard to speed bumps. What do you think? We don't want pets or children -- even

rabbits and squirrels -- hurt on our streets. ~Mike

Kids and Freon - Neighborhood Watch Issue

Individuals looking to get high have started a potentially fatal trend of huffing Freon gas from air conditioners which freezes the lungs and can be deadly on the first try.

We have already had a recent incident reported on Sundown Road where two units were damaged by this act and was confirmed by the repair company. In fact, the technician stated it was happening all over Knoxville and can end up being a very expensive repair.

They are tampering with refrigerate ports or interior lines on outdoor A/C

systems to gain access to the deadly chemical. The harmful effects of huffing Freon include brain mass loss, liver damage, cardiovascular issues and death.

Please be watchful for anyone hanging around A/C units, and call the Police if witnessed. Consider adding more exterior lighting and/or motion lighting around your home.

2013 proved to be another fun year at the Fort West pool. Over 60 residents joined the pool this year which provided funding for the new pool furniture and pump maintenance. Both pool pumps broke this year and were immediately replaced to provide for uninterrupted pool access.

Annual dues continue to allow for improvements for the members. Next year we will be replacing the plastic tables and purchasing new cabanas.

The current budget has \$8,800.00 in the resurfacing account and approximately \$7,000.00 in the checking account. A final financial statement will be posted at the end of the season. We look forward to another great year in 2014.

FWOA Board Meeting

Meeting was held at the Singletary home, 309 Lawton Blvd, September 9, 2013 at 4:30 p.m.

Attendees: Mike Singletary, Melissa North, Mark Stewart, George Nennstiel

The Board expressed thanks to George Nennstiel for raising the seasonal flags, and for arranging maintenance of the sprinkler system for the FWOA.

The Board was advised membership now stands at 170 for 2013, an improvement over previous years. Melissa North reviewed the budget and the Board was advised the FWOA financial situation is sound at this time.

The Board discussed the possibility of installing speed bumps or speed "humps" in key places on at least two streets, Lawton and Longbow, in response to complaints from residents about speeding cars. Mark Stewart will research the issue with the Town of Farragut, to include the feasibility of speed limit signs, and options for addressing issues of on-street parking.

The Board was asked about an autumn garage sale and a repeat of the Christmas home tour. Both items will be discussed further.

The Board was advised that the entrances will be decorated for autumn with pansies, same as last year. The flowers in 2012 provided great color and survived the winter. It was noted that the FWOA planting of summer petunias at the entrances of the subdivision failed, as all the plants died after some three weeks. Cause of the loss is not known.

Mike Singletary urged that the yard of the month competition and the annual neighborhood meeting be resumed, as called for in the by-laws.

The Board also discussed how to improve the gathering of news for the FWOA newsletter. News contributions will be promoted in the newsletter.

Regarding resumption of the annual National Night Out Program, the Board agreed that a chairperson should be solicited to take ownership, so to speak, of that program.

The meeting adjourned at 6:00 p.m.

Most drivers do not think that speeding is a serious offense, except where children might be present. Many drivers admit to speeding in residential zones. The reasons range from running late and wanting to make up time to being unaware of the speed limit. Speeding in residential zones are usually the number one complaint of neighborhoods, because of the risks to children. Speeding in residential zones causes five types of harm:

- Makes neighbors fear for children's safety
- 2. Makes walkers and bicyclists fear for their safety
- 3. Increases the risk of vehicle accidents
- 4. Increases the seriousness injuries
- 5. Increases engine and tire noise

Even small increases of speed can make the difference between life and death for pedestrians struck by a car or truck and each one-mph reduction in speed equal to a 5 percent reduction in vehicle accidents.

Remember that speeding contributes to 1/8 of all accidents and 1/3 of all fatal crashes.

Please slow down and following the posted speed limits for Fort West and surrounding areas.

Watt Road Extension Project Update

Alderman and Fort West resident Jeff Elliott informed the FWOA that the town of Farragut was notified by TDOT (which oversees this project) that the Watt Road Extension Project will probably not be completed until the spring of 2014. The contractor got behind with utility relocations and weather delays and the likelihood of completion before winter is remote.
